World Bunk Ald for Rejusthan Canal

Will the Minister of IRRIGATION AND POWER be pleased to state:

- (a) whether a team of World Bank has recently visited Rajasthan in connection with the aid given by the World Bank for Rajasthan Canal and Chambal Project; and
- (b) if so, the salient features of the Report submitted by the team to the Government of India?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION POWER (SHRI B N KUREEL): and (b). A World Bank Command Area Development and Irrigation Reconnaisance Mission arrived in India on 30th October, 1972, with a view to identify which could be taken up for IDA financing After their preliminary meeting with Government of India officials in Delhi they visited Chambal and Rajasthan Canal Command Areas. On return from their field visits, the Mission has given a questionnaire for collection of data necessary for the formulation of detailed project reports. The World Bank has not so far sanctioned any financial assistance for development of command area of Rajasthan Canal or Chambal. The project reports when prepared by the State Government according to the questionnaire of the World Bank Mission will be examined by the Government of India and sent to the World Bank for their consideration.
