Development of Pipavav and Salaya in Gujarat as Direct Berthing Port

*209. SHRI P. M. MEHTA: Will the Minister of SHIPPING AND TRANS-PORT be pleased to state:

(a) whether Gujarat Government have asked the Centre for the development of Pipavav on the Saurashtra coast as a deep water direct berthing port and of Salaya as a direct berthing port suitable for bulk-carriers; and

(b) if so, the reaction of the Union Government?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI RAJ BAHADUR): (a) Yes; the Government of Gujarat have suggested the development of the ports of Pipavav and Salaya under the Centrally Sponsored Schemes during the Fifth Five Year Plan.

(b) The proposals relating to the development of minor/intermediate ports during the Fifth Plan have not so fat been finalised. It is, therefore, not possible to indicate the Government's recation at this stage.

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB P. SHINDE): (a) The State Government has reported that no starvation death has taken place in Orissa this summer.

Jhuggi-jhonpris in New Delhi

(a) the number of jhuggi-jhopris in each residential locality in New Delhi;

(b) the facilities like water, electricity and other public conveniences provided for the dwellers of the jhuggi-jhonpris;

(c) whether there is any proposal to give them alternative accommodation; and

(d) if so, the location thereof?

THE MINISTER OF WORKS AND HOUSING (SHRI BHOLA PASWAN SHASTRI): (a) There are about 75 Jhuggi-Jhonpuri clusters in New Delhi consisting of nearly 19360 units.

(b) Under the Central Scheme of environmental improvement of slum areas, facilities like water supply, sewers, storm water drains, community baths and latrines, widening and paving of existing lanes and street lighting are provided in jhuggijhanpri areas situated on public lands which are not earmarked for clearance for a minimum period of 10 years.

The Plan will be finalised on completion of model tests for the Harbour lay outs indicated therein The model tests are at present being conducted
