Public Sector Undertakings without Chief Executives

Will the PRIME MINISTER be pleased to state:

(a) the names of the Public Sector Undertakings which are functioning without Chief Executives and since when;

(b) the reasons for delay in filling up these key posts; and

(c) the steps taken to fill up the vacant posts?

THE PRIME MINISTER (SHRI VISHWANATH PRATAP SINGH): (a) and (b). A list of public sector undertakings which are functioning without Chief Executives as on 31.7.90 is given in the Statement annexed. It may however be noted that interim arrangements are made pending regular-appoint-

ments in accordance with prescribed procedure, which involves circulation of vacancies, shortlisting of candidates, scheduling of interviews, verification of character and antecedents and also obtaining vigilance clearance of persons recommended for appointment. This process invariably takes time and delays occur mainly due to the following reasons:

- (i) Where the appointees take time to join or ultimately do not join resulting in fresh selection;
- (ii) Spotting of specific talents for specific posts which sometimes require Press advertisements in the leading news-papers of the country;
- (iii) Where vacancies cannot be foreseen such as arising due to resignation, death, premature termination of services, movement of personnel from one enterprise to another, etc.

(c) It is the constant endeavour of the Government to fill up the vacancies as quickly as possible and action is taken to achieve this objective. It may be added that the Government have recently issued instructions on the processing of appointments to the posts of part-time Chairman, Chairman-cum-Managing Director and Functional Directors in Central Public Enterprises and a time schedule has been prescribed in this regard.
