Udasar Village in Bikaner district acquired and the number of farmers affected thereby;

THE PRIME MINISTER (SHRI VISH-WANATH PRATAP SINGH): (a) 222 bighas and 7 biswas of land have been acquired and another 3014 bighas and 18 biswas of land were takenover by transfer from the State Government. Information in respect of the farmers affected is being collected.

- (b) Compensation has been paid to the State Government.
- (c) The compensation for 3151 bighas and 12 biswas of land was paid to the Government of Rajasthan between March, 1982 and November, 1983 at the rate of Rs. 15.00 per sq. yard. For the remaining 85 bighas and 13 biswas of land, payment was made in the months of December, 1983 March, 1986 and March, 1989 at the rate of Rs. 25.00 per sq. yard. Total compensation paid for the entire land acquired/transferred in Udasar village was Rs. 14,94,58,443.00.
