Governments and in the meeting of Central Advisory Board of Education in June, 1987. On the basis of these consultations, IGNOU formulated guidelines for State Governments for establishment of open universities. These guidelines are, by and large, being followed. IGNOU has also established a Co-ordination Council, whose membership includes Vice-Chancellors of State Open Universities, for co-ordination among open universities.

  - (b) if so, the details thereof;
- (c) whether the Archaeological Survey of India has done any survey and assessed the damaged caused to the temples;
  - (d) if so, the details thereof; and
- (e) the steps taken to conserve the national monuments?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DE-VELOPMENT (SHRI CHIMANBHAI MEHTA): (a) Yes, Sir.

(b) The news item interalia questions

whether the Lord Jagannath Temple, Puri has started crumbling and the idols installed in the main shrine are safe.

- (c) Yes, Sir.
- (d) The specialists of the Archaeological Survey of India and the Expert Committee on Lord Jagannath Temple, Puri have examined and assessed the damage in July 90. It is observed that only a part of the amalaka-stone of the *vimana* of the main shrine got detached and fell down on 14.6.90. Except for this damage, the temple is in a good state of preservation, and there is no danger posed to the images installed in the main shrine.
- (e) The following steps have been taken to conserve this ancient temple complex:—
  - (i) action has been initiated to conserve the damaged part of the amalaka.
  - (ii) removal of accretionary plaster from the surface of the main temple for exposing the sculptured surface as well as locate cracks if any.
  - (iii) replacement of corroded iron clamps/dowels with non-corrosive ones wherever necessary from the temple structure.
  - (iv) grouting of cracks/fissures on the structure with suitable material.
  - (v) chemical cleaning and preservation.
  - (vi) providing watch and ward and supervisory/ technical staff for the proper

maintenance and preservation of the monument.

## Funds for Development of Jammu and Srinagar Cities

Written Answers

1113. SHRI JANAK RAJ GUPTA: Will the PRIME MINISTER be pleased to state:

- (a) the funds provided by the Planning Commission for the development of Jammu and Srinagar cities under crore area development plan during the year 1989-90; and
- (b) the various developmental works undertaken and the money spent so far under the said scheme?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING AND MINISTER OF STATE IN THE MINISTRY OF PRO-GRAMME IMPLEMENTATION (SHRI BHAGEY GOBARDHAN): (a) An amount of Rs. 28 crores was approved by the Planning Commission for the core area development plan of Srinagar city for 1989-90; Rs. 23 crores in the form of additional Central assistance and the balance Rs. 5 crores through adjustment from the approved plan of the State of Jammu and Kashmir. In so far as Jammu and Kashmir, In so far as Jammu city is concerned, a proposal has been received for core area development of Jammu city for the Eighth Five Year Plan.

(b) The developmental works undertaken as part of the core area development programme of Srinagar city include construction of roads and bridges, development of taxi and bus stands, basic services, low cost sanitation and community latrines, construction of deep drains, desalting of city channels and flood spillways, development of playgrounds and stadia, libraries, reading rooms.

It is understood from the State Government that an expenditure of Rs. 22 crores is expected to be booked against the Srinagar scheme upto March, 1990.
