ised educational institutions in the country has increased very much; and

(f) the steps AICTE has taken to curb the mushroom growth of these institutions.

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DE-VELOPMENT (SHRI CHIMANBHAI MEHTA): (a) and (f). As provided in the AICTE Act, the Executive Committee of the All India Council for Technical Education has approved guidelines for admission which have been circulated to all concerned. As regards tuition fees the Committee was of the view that there is an urgent need to bring fees in technical institutions to a realistic level so that there is some reasonable relationship between the fees charged and the actual cost of training. The present tuition fee being charged in Government and Government aided institutions is of the order of Rs. 200 to Rs. 400 per annum, which remains mostly at per-independence level. As against this, private engineering colleges in the following States are charging high fees at the rates indicated against each:

The difficulty, however, is that the paying capacity of an average Indian is limited

and if the fees are raised beyond paying capacity, some loan arrangements to stu-

dents may have to be made which could be returned over a period of time after they enter into employment. This will give opportunity to meritorious students of weaker sections and not only to those who can afford to pay more fees.

All technical institutions have to follow these guidelines and the defaulting technical institutions can be derecognised. These steps will curb the evil practice of charging capitation fee.

Norms and standards for degree courses in Engineering & Technology, Management, Pharmacy and Architecture as also norms and standards for diploma courses in Engineering & Technology and Pharmacy have been prepared and updated. These have to be adopted by all technical institutions. Further, no new institutions can now be set up without the prior approval of AICTE.
