AGRICULTURE (SHRI NITISH KUMAR): (a) and (b). The Registration Committee set up under the insecticides Act, 1968 have registered 25 weedicides under the Insecticides Act, 1968. Out of these, Dalapon, Paraquat and 2, 4-D are affective in controlling the acquatic weeds. No negative list is prescribed by the Registration Committee for pesticides which cannot be used for a particular pest problem.

# Expansion of Telephone Exchanges in Kerala

## Drinking water problem in Villages in Andhra Pradesh

- 1183. SHRI B.N. REDDY: Will the Minister of AGRICULTURE be pleased to state:
- (a) the number of villages in Andhra Pradesh facing acute drinking water problem as on date; and
- (b) the steps taken or proposed to provide drinking water in these villages?

THE MINISTER OF STATE IN THE DEPARTMENT OF RURAL DEVELOP-MENT IN THE MINISTRY OF AGRICULTURE (SHRI UPENDRA NATH VERMA):
(a) and (b). The are no 'problem' villages in Andhra Pradesh as on 1.4.1990. During

1990-91 against the targetted 1000 Partially Covered villages, 149 have already been covered. Under the Accelerated Rural Water Supply Programme during the 7th Plan against an allocation of Rs. 105.67 crores an amount of Rs. 108.38 crores was released. For three Mini Mission districts in Andhra Pradesh viz. Kurnool, Mehboobnagar and East Godavari against the approved cost of Rs. 11.54 crores, an amount of Rs. 6.78 crores has been released.

### Chakma Refugees in Tripura

1184. SHRI SANAT KUMAR MANDAL: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether the president of Chakma Refugees Association came to Delhi some time ago to apprise the Government of the various problems facing these refugees;
  - (b) if so, the details thereof, and
- (c) total expenditure incurred by Government on Chakma Refugees till July 1990 and the nature of facilities provided to them?

ernment so far the maintenance of tribal refugees from Bangladesh. The refugees are being provided food, clothing, shelter, educational and medical facilities etc. pending their return to Bangladesh.

However, the National Cooperative Development Corporation has sanctioned 430 mechanised boats including FRP canoes and Beach Landing craft to Fishermen Cooperatives during the last three years, the details of which are given below:-
