Apart from this, the families of Government employees including the Police/Security Personnel who die in harness are eligible for sanction of family pension, group insurance settlements and other benefits as applicable under the respective Service Rules.

**Javalgere Central State farm in Karnataka**

1226. SHRI H.S. SRIKANTIAH: Will the Minister of AGRICULTURE be pleased to state:

(a) whether Javalgere Central State Farm in Karnataka is under the control of Union Government;

(b) if so, the total acres of land in the above farm;

(c) whether Karnataka University has requested to hand over the above farm to it to take up research projects; and

(d) if so, whether Government have taken any decision in this regard?

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI NITISH KUMAR): (a) Central State Farms, Javalagere, Distt. Raichur, in Karnataka is being managed by the State Farm Corporation of India (A Govt.

of India Undertaking).

(b) The total area of the farm is 2960 hectares.

(c) The State Government of Karnataka requested for handing over of this farm initially for Agricultural University, Bangalore and subsequently for the University of Agricultural Sciences, Dharwad.

(d) The Government of Karnataka was intimated that the State Farms Corporation of India would be able to spare 200 hectares of un-irrigated land of this farm, to the State Government, on payment basis.

THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATIONS (SHRI JANESHWAR MISHRA): (a) Yes, Sir. A Design Sub-Committee of the Philatelic Advisory Committee has been constituted.

(b) No particular criteria has been laid down for the constitution of the Design sub-Committee. The Sub-Committee consists of official and non official members. Official members include the officers concerned with the designing of stamps. The non-official members include eminent artists and philatelists.

The constitution of the present Designs Sub-Committee is At Statement I enclosed.

(c) Though no particular criteria has been laid down for the constitution of the Committee, the Committee consists of the concerned official and non official members. Non official members are generally drawn from amongst MPs, prominent philatelists, philatelic dealers, artists and eminent persons from various fields. The official members are from the Govt. departments dealing with the subject.

(d) Yes, Sir.

(e) Details of public representatives in the philatelic Advisory Committee and Design Sub-Committee are at Statement II and III respectively.

(f) Does not arise in view of (d) above.
