1283. SHRI Y. S. RAJA SEKHAR REDDY: SHRI UTTAM RATHOD:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether there is a proposal to convene a "round table" conference of Babri Masjid Action Committee, VHP representatives and Government to consider the Ram-Janam Bhoomi issue:
 - (b) if so, the details thereof;
- (c) whether any efforts are being made by Government to have the hearing of the case in the High Court expedited; and
- (d) if so, when is the matter likely to be taken by the Court for hearing?

(c) and (b). The State Government of U.P. is a party to the case before the High Court. The Court has resumed the hearing of the matter after summer vacations. It is now listed for further hearing on the 22nd August, 1990.
