1295. PROF. GOPALRAO MAYEKAR: Will the Minister of SURFACE TRANS-PORT be pleased to state:

- (a) whether there is any proposal to resume the steamer service between Goa and Bombay after the monsoon is over;
 - (b) if so, the details thereof; and
 - (c) if not, when it is likely to be resumed?

THE MINISTER OF SURFACE TRANS-PORT (SHRI K. P. UNNIKRISHNAN): (a) to (c). A decision is yet to be taken in this regard. The Union Government is discussing the question of re-introduction of this service and its viability with the concerned State Governments.
