Sant Tukdoji Cancer Hospital and Research Centre as a Regional Cancer Centre. A reply was sent to the Govt. of Maharashtra and the ciety in April, 1989. During the 8th Five Year Plan emphasis is on prevention and early detection of cancer and there is no proposal to convert medical institution into a Regional Cancer Centre.

## Transfer of DDA Land/Flats

MINISTER OF URBAN THE (SHRI MURA-DEVELOPMENT SOLI MARAN): (a) and (b) As per current guidelines transfer of DDA flats is allowed not only between the blood relations but also in cases of transfer of flats on the basis of general power of attorney and agreement to sell after recovery of 50°% earned increase in the value of land.
