1977 contained references implying involvement of India in the incidents that took place in Bogra and Dacca in Bangladesh on 30th September and 2nd October, 1977.

(b) and (c). The matter was taken up immediately with Government of Bangladesh which has assured the Government of India that there has been no intention on the part of Bangladesh Government to $impl_y$ India's involvement in these inncidents.

(ग) सभी सरकारी प्रधिकारियों से यह प्रत्याशा की जाती है कि उन्हें अंग्रेजी और हिन्दी दोनों ही भाषाओं का कार्यसाधक ज्ञान हो ग्रौर जो भी भाषा वे सुविधाजनक पायें उसका प्रयोग कर सर्के ।

Integrated Leprosy Control Programme

*69. SHRI R. D. GATTANI: SHRI UGRASEN:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether the integration of leprosy, control programme with general health services relating to multipurpose workers scheme has aroused opposition from the National Leprosy Organisation, Wardha;

(b) whether the National Leprosy Advisory Committee was consulted before this policy decision was taken; and

(c) whether leprosy programme is not like malaria, family welfare or small pox programmes which can be integrated and that the country still needs a vertical leprosy control programme?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI RAJ NARAIN): (a) Yes, Sir.

(b) Since integration of all health programmes including Leprosy, Cholera, T.B., Malaria etc. were concerned it was not considered necessary to consult only the National Leprosy Advisory Committee before taking the policy decision.

(c) Leprosy control work will not be integrated with the general health services in the entire country for the present. The intention is that all health programmes will be integrated with the Multi-purpose Workers Schemes in the districts taken up for the implementation of that scheme but the scheme itself will be introduced progressively only in the districts where Leprosy and other public health problems are not in hyper-endemic stage. In other districts, Leprosy will continue as a vertical programme.

Legislation to repeal the provision of Pension to Former M.Ps.

*70. PROF. P. G. MAVALANKAR: Will the Minister of PARLIAMEN-TARY AFFAIRS AND I ABOUR be pleased to state:

(a) whether Government have now considered the question of pensions to former Members of Parliament being eliminated or increased;

(b) if so, the facts thereof, including the manner in which Government propose t_0 implement their decision and when;

(c) if not, reasons therefor; and

(d) whether Government propose to bring forward during the Winter Session, 1977 the legislation for repeal of the provision of pensions to former M.Ps. and if so, broad indications thereof?

THE MINISTER OF PARLIAMEN-TARY AFFAIRS AND LABOUR (SHRI RAVINDRA VARMA): (a) to (d). Representations have been received toth for repealing the provisions regarding the granting of pension to ex-Members of Parliament and also for liberalising them. The whole matter is still under consideration of the Government. A decision will be taken after Government has had discussion with the Leaders of opposition parties/groups in the two Houses
