

**Stand taken at Special U.N. Assembly Session on Disarmament**

\*79. SHRI CHITTA BASU: Will the Minister of EXTERNAL AFFAIRS be pleased to refer to the reply given to Short Notice Question No. 7 on the 4th May, 1978 and state:

(a) whether India participated in the special session of U.N. Assembly on disarmament;

(b) if so, the broad outline of the stand taken by the Indian representatives; and

(c) broad assessment of the results of this special disarmament session?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI ATAL BIHARI VAJPAYEE): (a) Yes, Sir.

(b) India worked in close concert with the other non-aligned countries with a view to developing consensus amongst all Member States of the United Nations on a common strategy as well as concrete measures for achieving real progress in the field of disarmament, particularly nuclear disarmament.

(c) In India's view, although the Special Session did not achieve any spectacular results, the consensus Final Document, which has emerged from the Session, contains several positive features particularly in regard to the Programme of Action covering both nuclear and conventional disarmament and in respect of Machinery for future disarmament deliberations and negotiations.

**Steel Export Commitment during Current Year**

(a) what are our steel export commitments during the current year;

(b) whether it is a fact that steel export has been adversely affected due to price hike and imposition of development cess; and

THE MINISTER OF STEEL AND MINES (SHRI BIJU PATNAIK):

(a) Country's export commitment for steel during the current year so far is 635,900 tonnes valued approximately at Rs. 121 crores.
