Recovery of Income Tax Arrears from Sterling Tea Companies operating in India

*72. SHRI K. A RAJAN: Will the Minister of FINANCE be pleased to state:

- (a) the steps being taken to recover the Income tax arrears from sterling tea companies operating in India which were piled up due to tax evasion by these companies; and
- (b) at what stage the matter stands at present?

THE MINISTER OF STATE THE MINISTRY OF FINANCE (SHRI ZULFIQUARULLAH): (a) and All necessary steps are being taken to recover the income-tax demands raised in the cases of the Sterling Companies. These demands have been raised recently in respect of the gross commissions paid to their U.K. Secretaries and Agents. The demands are under section 201 of the Incometax Act, 1961 which deems the payer of any amount as assessee in default, if tax was not deducted at source from such payments. The payees i.e. the UK Secretaries & Agents are taxable only on that portion of their income which is attributable to oprations carried out in India vide section 9(1)(i) of the I. T. Act, 1961.
