## Kashmir

\*449. SHRI G. M. BANATWALLA: SHRI MUKHTIAR SINGH MALIK:

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether the Chief Minister of Jammu and Kashmir State has sometimes back approached the Central Government to relax restrictions on movement of people across the line of actual control in that State;
  - (b) if so, the details thereof; and
  - (c) Government's reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL SAMARENDRA AFFAIRS (SHRI KUNDU): (a) and (b). The Chief Jammu & Kashmir, Minister of Sheikh Abdullah, had brought to the attention of Government difficulties being experienced by persons in that State in meeting their relatives from the other side of the Line of Control. Government have noted statements made by the Chief Minister urging that steps should be taken to facilitate such movement to enable people in the State to meet their relatives.

(c) The inconvenience and hardship involved has received the careful attention of Government. It is our policy to ease restrictions on travel as much as possible.

- (a) whether a special Conference on Rural Unorganised Labour held at New Delhi on 25th January, 1978 had recommended setting up of a Central Standing Committee on rural unorganised labour;
- (b) if so, whether the said Committee has not been set up as yet;
- (c) if so, the details and reasons therefor; and
- (d) by when it is expected to be constituted?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND PARLIAMENTARY AFFAIRS (SHRI LARANG SAI): (a) Yes, Sir.

(b) to (d). Action has already been initiated to settle the details with regard to the Constitution of the Central Standing Committee on Rural Unorganised Labour. A decision in this regard is likely to be taken soon.
