- (b) the name or names of the Commissions; and
- (c) the terms of reference of the various Commissions appointed and the period within which the Commissions are expected to report?

THE MINISTER OF HOME AF-FAIRS (SHRI CHARAN SINGH): (a) Six Commissions have been appointed at the Centre since the Janata Party has come into power.

(b) and (c). The relevant Notifications appointing the Commissions are laid on the Table of the House [Placed in Library, See No. LT. 473/77].

Flans for Backward Districts

*149. SHRI S. D. SOMASUNDA-RAM: Will the Minister of PLANNING be pleased to state:

- (a) the present position of implementation of recommendation of Estimates Committee in paras 2.109-2.110 of their 69th Report (5th Lok Sabha) regarding formulation of district plans for each backward district;
- (b) the number of districts which have been covered, particularly in Tamil Nadu;
- (c) the stages of implementation of such plans; and

(d) whether Government propose to make a review of such plans with a view to making them realistic and amenable to orderly fulfilment?

THE PRIME MINISTER (SHRI MORARJI DESAI): (a) Following the recommendations of the Estimates Committee, the Planning Commission had impressed upon the State Governments the need for taking steps for the formulation of district plans.

- (b) The position in March, 1976 was reported to the House in reply to part (b) of Lok Sabha Unstarred Question 1272 answered on 24th March. Tamil Nadu had even then prepared district perspective plans for 23 development districts through 13 district planning cells and techno-economic feasibility studies had been completed backward disfor more industrially tricts, viz. Ramanathapuram, Dharmapuri Thanjavur and South Arcot Report on the present position of the the plans has been called for from State and will be laid on the Table of the House.
- (c) The implementation of the plans will depend on the resources that can be earmarked for the various parts of the plan from the State Plan resources. As regards present position information has been called for and will be laid on the Table of the House when received.
- (d) The main parameter for a district plan is that it must be realistic and be capable of performance within a reasonable time frame. With the present thrust on integrated rural development and employment, the district plans will be reviewed and the work will be taken up as preparatory to the Sixth Plan Programme.
