endeavouring to procure orders from the Defence Department for certain instruments and are taking steps to diversify their production programme towards lines where there is demand. It is expected that with a diversified programme, the production level will pick up. Both the Management and the Government are already scized of the problem and the question of appointing a Committee to enquire into the working of the Company does not arise.

Export of Coal

Will the Minister of Commerce be pleased to state:

- (a) the steps taken by Government for stimulating the coal consumption;
- (b) whether there has been a decline in the export of coal during the last two years; and
- (c) if so, how Government propose to step up the export of coal?

The Deputy Minister in the Ministry of Commerce (Shri Shafi Qureshi): (a) to (c). The following measures have been taken to stimulate the consumption of coal in the country:--

- (i) Relaxation of price and distribution controls over coal/ coke;
- (ii) liberalisation oflicensing policy with regard to opening of brick kilns and soft coke. depots; and
- State Govern-(fii) advising the ment to encourage the growth of coal-based industries and to restrict the use of fire wood and Charcoal in industrial furnaces.

India used to export about one million tons of coal to Pakistan before the Indo-Pakistan conflict of 1965. Excepting exports to Pakistan. total exports of coal and coke to other countries have increased from 0.207 million tonnes in 1964-65 to 0.216 million tonnes in 1965-66, and 0.368 million tonnes in 1966-67. Measures for securing increased exports to Burma/ Cevlon are being taken. Also possibilities of exporting Indian coal to Hongkong, Japan and other countries are being explored.

Zinc Smelter near Udaipur

*1766. Shri S. M. Banerjee: Shri S. S. Kothari: Shri Madha Limaye: Shri George Fernandes: Shri Onkarlat Bohra:

Will the Minister of Steel, Mines and Metals be pleased to state:

- (a) whether it is a fact that the erstwhile Metal Corporation of India had declared that the Zinc Smelter would come into operation in three stages i.e., by July. 1966. January, 1967 and then 3rd quarter of 1967;
- (b) if so, whether the progress at the installation of the Zinc smelter is very slow;
 - (c) if co, reasons therefor;
- (d) whether it is also a fact that the Zinc Smelter could have come into operation by the first quarter of 1965: and
- (e) if so, the reasons for this abnormal delay?

The Minister of Steel, Mines and Metals (Dr. Chenna Reddy): (a), (d) and (e). According to a Memorandum submitted by the Metal Ccrporation of India to the Government in September, 1963, the Zinc Smelter was to come into operation in September/October, 1964; after the start up operation lasting about three months, the production in the

year of operation i.e., 1965 was expected to be 60 per cent of the rated capacity of 18,000 tonnes per amum and in the following year i.e., 1966 about 80 per cent of the capacity. However, the company having run into financial difficulties it could not complete the project and commence operation according to the time schedule indicated by it.

(b) and (c). After the acquisition of the undertaking of the Motal Corporation of India with effect from 22-10-1965, the Hindustan Zinc Limited, a Government Company, which was formed to manage the undertaking of the Metal Corporation of India, has made considerable progress in completing the smelter project which is now likely to be commissioned by the last quarter of this year.
