## INDO-U.S.A. RELATIONS

\*594. SHRI HIMATSINGKA : Will the Minister of EXTERNAL AFFAIRS be pleased to state :

(a) whether Government's attention has been drawn to the reports that the resolution on West Asia co-sponsored by India has resulted in growing distrust between India and U.S.A. over West Asia; and

(b) if so, Government's reaction for improving the Indo-U.S. relations by removing any misunderstandings from U.S. mind?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) : (a) and (b). It is true that there have been some differences between India and the USA regarding the basis on which a peaceful solution in West Asia could be found. These differences were reflected in the Three Power draft resolution co-sponsored along with others, by India and the one sponsored by the U.S.A. It is, however, not correct to say that this has resulted in growing distrust between India and the U.S.A. over West Asia. Differences between the two countries have been frankly dis-Both India and the U.S.A. cussed. have since voted for the resolution unanimously adopted by the Security Council on 22nd November, 1967.
