THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI F. A. AHMED): (a) and (b). Messrs. Coca-cola Export Corporation, which is a cent per cent subsidiary concern of the foreign firm Coca-cola of U.S.A., produce Coca-cola concentrate in India.

- (d) The total production of Cocacola concentrate in 1967 was of the order of Rs. 1.6 crores of which Cocacola concentrate worth Rs. 1,2 crores was consumed internally.
