5990. SHRI SRINIBAS MISRA: Will the Minister of INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS be pleased to state:

(a) the value of total production of the Hindustan Photo Films Manufacturing Company for the year 1967-68 and how much of it is cine film positive colour;

(b) the cost of raw material consumed for this production;

(c) whether it is a fact that about three fifths of the total production is lying unsold; and

(d) whether there is any proposal for diversification of production and if so, the details thereof?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI F. A. AHMED): (a) The value of total production of Hindustan Photo Films Manufacturing for the year 1967-68 (upto February, 1968) is 123.27 lakhs which includes converted X-Ray Film. There was no production of cine film positive colour.

(b) Rs. 82.40 lakhs.

(c) No. Sir.

(d) It is proposed to diversify production during the fourth plan period to include manufacture of Technicolour Blanks and Multilayer Colour, besides taking up manufacture of roll-film, bica film and portrait film.

Appointment by S.T.C. of Raja Oil Mills as clearing Agents

5991. SHRI BABURAO PATEL: Will the Minister of COMMERCE be pleased to state:

(a) whether it is a fact that the State Trading Corporation, Bombay has given clearing and transport work in respect of thousands of tonnes of soyabean oil to M|s, Raja Oil Mills, who are not licensed clearing agents;

(b) the terms of charges and commission on which the above contract has been given to M|s. Raja Oil Mills and the reasons for giving contract to this firm; and

(c) the amount of charges annually paid to the above firm during the last three years?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI MOHD. SHAFI QURESHI): (a) The S.T.C. called for quotations from three leading firms for handling consignments of 18,300 tonnes of soyabean oil. One of them did not quote for this work and of the other two quotations, the one received from M/s. Raja Oil Mills was the lowest. Since M/s. Raja Oil Mills are not licensed for customs clearance, they have, it is understood, acquired the services of clearing agent for this purpose.
