## Pak. Nationals in Kutch

\*1080. SHRI SRINIBAS MISRA: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that a large number of Pakistani nationals who entered Kutch in 1960 on visas have stayed over after the expiry of their visas and have gone underground;

(b) the number of such persons and ostensible purposes for which they were granted visas; and

(c) the steps being taken by Government for repatriating them?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) No, Sir.

(b) Their number was only 51. They were granted visas to see their relatives.

(c) Out of these 51 persons, 34 have since been sent back to Pakistan, 4 have filed civil suits claiming to be Indian citizens and 9 are women, who have either married Indian citizens or are old and infirm, and they have been advised by the State Government to apply for the grant of facilities for continued stay in India. All possible efforts are being made to trace out the remaining 4 persons who are still underground.

## Request by Zambia to operate their Airlines

•1081. SHRI NITIRAJ SINGH CHAUDHARY: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

(a) whether the Zambia Government have requested the Government of India to take over and run their Airlines;

(b) whether on India's refusal, they have handed over their airlines to Alitalia; and

(c) if so, the reasons therefor?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a) Government of India have not received any request from the Government of Zambia to take over and run their airlines.
