- (a) whether the U.K. Government have finally set up the proposed tribunal to divide the contents of the India Office Library in London between India and Pakistan;
- (b) If so, the names of the membeen of the tribunal;

- (c) if the reply to part (a) showe be in the negative the reason for the delay in appointing the cribital;
- (d) the steps Government taking to selve this problem?

THE MINISTER OF EDUCATION (DR. TRIGUNA SEN): (a) No, Sir.

- (b) Does not artise.
- (c) and (d). The terms of reference of the proposed Tribunal theve not yet been agreed upon by all concerned. While the Government of India have agreed to the proposal of the Government of the U.K. regarding the system of law to be applied by the Tribunal for the settlement of the question, the decision of the Pakistan Government on this issue is still awaited. The need for an early settlement of the question was pointed out to the British Secretary of State for Commonwealth Affairs in December, 1967. The U.K. Government are continuing their efforts to get the reply of the Pakistan Gowernment.
