- \*1520. SHRI M. L. SONDHI: Will the Minister of HEALTH. FAMILY PLANNING AND URBAN DEVELOP-MENT be pleased to state :
- (a) whether Government are aware of the strong action threat from the Teachers' Committee of the Tibbia College against the Management Board for its anti-education and anti-teacher tactics :
- (b) if so, the demands of the teachers and whether they have been considered; and
  - (c) the action taken thereon?

THE MINISTER OF HEALTH, FAMI-LY PLANNING AND URBAN DEVELOP-MENT (SHRI SATYANARAYAN SINHA): (a) No such resolution or communication has been received from the Adhyapak However, press reports of a threat of action have come to the notice of the Delhi Administration.

- (b) The demands of the teaching staff include revision of pay-scales, grant of nonpractising allowance and other allowances, payment of gratuity and pension. The same have been considered by the Ayurvedic and Unani Tibbia College, Board.
- (c) The recommendations of the Board are under consideration of the Delhi Administration.

# Domestic Power for Types II & III Quarters in Delhi

#### \*1521. SHRI HARI KRISHNA: SHRI JAGESHWAR YADAV:

Will the Minister of WORKS, HOUS-ING AND SUPPLY be pleased to state:

- (a) whether it is a fact that domestic power has not been provided in types II and III Government quarters in Delhi;
- (b) whether it is also a fact that those allottees who ask for power have to instal it at their own cost in the quarters; and
  - (c) if so, the reasons therefor?

THE MINISTER OF WORKS, HOUS-ING AND SUPPLY (SHRI JAGANATH RAO): (a) Yes, Sir.

(b) and (c). It has recently been decided to provide one A. C. power plug per house on request from individual tenants. Government's liability in each case will be limited to Rs. 200/- and the tenants will have to pay additional rent on it. Any expenditure in excess of Rs. 200/- is to be borne by the tenants themselves.
