commendations of the Committee. However, the implementation of these recommendations, by their very nature, would take time and it is too early to say at this stage whether the quality of cars manufactured in the country has improved during the last six months.

In the meantime, in pursuance of one of the recommendations of the Committee, a team of experts has been deputed to visit the plants of the three car manufacturers with a view to assisting and advising the latter in strengthening their internal inspection organisation. The Team will also suggest to Government the kind of external inspection organisation that should be set up to supplement the internal arrangements and how it can be made to function effectively. Further action in the matter will be taken on receipt of the report of the Team.

- \*297. SHRI BABURAO PATEL: Will the Minister of STEEL AND HEAVY ENGINEERING be pleased to state:
- (a) whether it is a fact that Mr. Skatchkov, Soviet Chairman for Economic Relations with foreign countries, during his recent visit to Bhilai and Ranchi, said that he was dissatisfied with the performance of these projects and suggested "speedy corrective measures"; if so, the salient features of the report submitted by Mr. Skatchkov ond the corrective measures suggested; and
- (b) the precise steps taken by Government to improve steel production?

THE MINISTER OF STEEL & HEAVY ENGINEERING (SHRI C. M. PONACHA) (a) and (b). The working of Bhilai Steel Plant and Heavy Engineering Corporation, Ranchi were among the Soviet aided Projects which were reviewed by the Shatchkov Delegation and the representatives of the Indian Government. Various steps and measures to improve the efficiency of these units were discussed. These are under consideration for implementation.

## Steel Quota given to Standard Drum Manufacturing Company

- (d) whether his Ministry, in consultation with the Ministry for Industrial Development, Internal Trade and Company Affairs and the Finance Ministry have taken any steps to prevent the malpractices and tax evasion resuiting from this quota allotment; and

THE MINISTER OF STEEL AND HEAVY ENGINEERING (SHRI C. M. POONACHA): (a) A Memorandum covering a number of points including a reference to the steel quotas given to this firm, has been received by the Ministry of Industrial Development, Internal Trade Company Affairs, and it reported to be under examination in that Ministry.

- No. Sir. Whereas there (b) and (c). is no statutory control over steel prices. and the selling prices at the level of the main producers are fixed by the Joint Plant Committee, there is no formal or informal regulation over the prices at the wholesale and retail levels.
- (d) and (e). If any specific malpractices and tax evasions come to Government's notice, appropriate action will be taken by the concerned Departments.

THE MINISTER OF INDUSTRIAL DEVELOPMENT, INTERNAL TRADE AND COMPANY AFFAIRS F. A. (AHMED): (a) Yes, Sir,

- Messrs Madras Rubber Factory Ltd., Madras.
- (c) Funds available from the Cooley loan are intended for meeting rupee expenditure on the acquisition of additional land, construction of buildings. payment of duty as also the installation of plant and machinery. The repayment of loan is envisaged in fourteen approximately equal semi-annual instalments, the first instalment to be due and payable three years from the date of first disbursement. The loan carries an interest of 8% per annum.
