Pandha was in the first floor in room No. 37. There were two other research scholars who were working in the ground floor and as soon as the fire came, the two people below rushed out and contacted the fire brigade, and the fire brigade came there within 20 minutes.

The circumstances under which Dr. Pandha died are rather strange. There was an inquiry conducted by the University authorities. The Police also conducted an inquiry and it was found that it was either an accident or it should be a matter of suicide. I have gone through the findings and I myself suggest not only due to the respectful memory of the young lady but also from the point of feelings of the family, that there is no point in going in detail into the incident. I don't think it will help anybody, it will only aggravate the feelings of the family who have already suffered a serious loss on account of the death of their daughter.

Anti-National Activities of Naxalities

*814. SHRI N. SHIVAPPA: SHRI D. R. PARMAR: SHRI R. R. SINGH DEO:

Will the Minister of HOME AFFAI-RS be pleased to state:

- (a) whether numerous people were mercilessly killed, injured, or otherwise, harassed by the increased lawless activities of the Naxalites in various parts of the country:
- (b) if so, total number of people killed and the extend of property destroyed by the Naxalites during the last six months; and
- (c) the action, if any, taken by Government of India with a view to strengthening the hands of the State Governments to deal with this menace of anti-national and anti-social force?

THE MINISTER OF HOME AFFAIRS (SHRI Y. B. CHAVAN) (a) and (b). A statement is laid on the Table of the House.

(a) and (b). According to information received from the State Governments, during the last six months 27 persons were killed and property worth Rs. 5,28,361/- was looted destroyed by the extremists in Andhra Pradesh. In Bihar the extremists were responsible for two decoities and an incident of rioting, in which 4 persons were killed and property worth about Rs. 10,000/- was looted injuries or destroyed. In Punjab were caused by extremists to two persons. Investigation in respect of incident which took place in June, 1969 in district Hoshiarpur resulting in the death of three persons, is in progress. In Uttar Pradesh, the extremists were responsible for two cases of robbery, burglary in which they looted one rifle, two guns and a revolver, besides other property worth Rs. 815/-. They also caused injuries to some persons. In West Bengal 1 person was killed, thirty nine persons were injured and six otherwise herassed by the extremists who also caused damage to some Government and private property. There were no such incidents in the remaining States/ Union territories.

(c) The State Governments are taking action under law to deal with the violent activities of the extremists. The Central Government has been keeping in close touch with the State Governments.

SHRI N. SHIVAPPA: In our land, Kerala, West Bengal, Kashmir and so on are border States which have already suffered due to the highhanded activities of the Naxalites. The

law and order situation has been completely paralysed. In view of this there was a CBI inquiry which was going on and the report was expected. I want to know categorically from the Home Minister whether he is going to allow this question of high handed action of the naxalites to operate lawin almost all parts of [†] Does country? he think that any action is called for from central control of his own in his capacity as a Minister? Secondly, Sir, I want to know whether the CBI report has been submitted. If so, what action is the Central Government proposing to take ? (Interruption) It is our feat that the Central Government will go into action only when the matter goes beyond control. In the condition of our society today, should we allow such a situation to develop like this?

SHRI Y. B. CHAVAN: I have said there is no question of condoning or ignoring what is happening in different States. In this matter I that the State Governments are very much wide awake to the situation. In all the States we find this and even West Bengal Government is aware of it and the political danger which it involves, and they are trying to take what suitable action think is necessary. I find that Andhra Government also is taking very serious notice of what is happening in Sreekakulam district where they have been more active in the recent weeks. The same thing is there about U.P. and I should say, about Punjab. House will remember that a few weeks before there were certain activities noticed in parts of Kerala also. I was very glad and I am very glad Kerala Government took that even some energetic action against these activities. So, there is no question of condoning or being ignorant of or ignoring the activities of these elements At the same time one should not take a panicky view or exaggerated view of these matters.

SHRI N. SHIVAPPA: Sir, we find that in our country, on various police stations these naxalites have hoisted
