## Construction of Houses for Lower Income Groups from L.I.C. income

(a) whether Government are considering to invest 5 per cent of the income from Life Insurance Corporation premia to construct houses for the lower income groups; and

(b) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF SUPPLY AND IN THE MINISTRY OF FINANCE (SHRI R. K. KHADILKAR) : (a) and (b). While no such specific proposal is under consideration of Government, LIC has been assisting in the development of housing facilities for different sections, including the lower income groups, through various loan programmes. The following are the different categories of loans now given :---

- (i) Loans to individual policy-holders under 'Own Your Home Scheme'.
- (ii) Mortgage loans for construction of new houses.
- (iii) Loans to Apex cooperative building societies.
- (iv) Loans to joint stock companies for providing housing to their staff.
- (v) Loans to cooperative societies formed by employees of the LIC.
- (vi) Loans to State Governments for purposes of housing.
