The Minister of State in the Ministry of Food, Agriculture, Community Development and Cooperation (Shri Annashib Shinde): (a) No, Sir. The subsidy was only reduced but not withdrawn.

(b) Does not arise.

(c) to (e). The Central Government revised its issue prices of coarse rice from 15th December, 1966. At that time the Government of Kerala requested that the revision should not apply to Kerala and should be defer-They further requested that the Central Government should give a grant to Kerala Government to enable them to continue to assue coarse rice on the basis of old pre-revised prices. The Kerala Government was informed that the revision in prices applied to all States and not to Kerala only and that it would not be possible to postpone giving effect to the increase in case of Kerala only. The Kerala Government was also advised that if they considered it inadvisable to increase the issue price to the consumers, they might consider bearing the cost of additional subsidy out of their own funds, and that they might take up the case with the Government of India for a suitable adadvance towards the end of the financial year if it was found that they were unable to pay the cost out of their own funds.
