to continue to import foodgrains from abroad.

(b) In most of the States, the F. C. I. is now incharge of procurement of foodgrains Procurement through cooperative organizations and also through direct Government agencies is also in operation in some of the States. The system adopted is working satisfactorily, though improvements are being made and will be continued to be made wherever they are found necessary. Distribution of Government stocks of foodgrains is made mainly through ration shops and fair price shops and this system is functioning more or less satisfactorily.
