(2) Special feeding programmes are being run with the help of the Indian Red Cross Society, CARE and UNICEF;

(3)86.29 million doses of small pax vaccine (freeze dried) have been supplied to the State Government;

(4) Materials for production of 285laths doses of cholera vaccine and 100 laths doses of T.A.B. vaccine have been received from UNICEF and the production of vaccines is being undertaken;

(5) 408 bottles of 1 litre each of Aminofiam (protein hydrolystate) have been supplied to the State. Government for treatment of scute cases of mal-nutrition; and

(6)For improving the arrangements for drinking water supply drilling rigs, hand-water pumps, water testing kits and chlorinating units have been obtained from UNICEF and supplied to the State Government. More such equipment is being obtained.

Advances by Banks against Foodgrains
