

Trust were paying to the Port Trust. Will the Government take it up with the Shipping Ministry and see that this recommendation is also accepted?

SHRI BHAGWAT JHA AZAD : It is true that while accepting this recommendation we have said that we will separately deal with this. We have taken up this question with the Transport Ministry.

SHRI MANUBHAI PATEL : Since the hon. Minister has recommended the recommendations of the Wage Board to the respective States, may I know which are the States which are reluctant to accept the recommendations, and which are the States which have accepted or are favourable to these recommendations of the Wage Board?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI D. SANJIVAYYA) : I may correct the impression given to the hon. Members by my colleague. In the case of port and dock workers, the appropriate Government for implementation of the recommendations is the Central Government.

SHRI MANUBHAI PATEL : He said it is the State Governments.

SHRI D. SANJIVAYYA : My colleague, while generally replying to the question of wage boards, said that in certain cases the appropriate Government is the State Government, in which case we appeal to the State Government to see that the recommendations are implemented, but in the case of mines, port and dock workers, railways and so on, the appropriate Government is the Central Government, and it is our responsibility, and we will see that they are implemented.

SHRI CHENGALRAYA NAIDU : Here in India we have got some moral standards and we import films without those moral standards, immoral films so to say, and they are screened here in our country. What will happen to the younger generation? They will see those films and get spoiled. May I know from the hon. Minister whether at least hereafter when they allow other countries to screen their films here they will take steps in advance to see that such bad films are not screened here in India?

SHRI I. K. GUJRAL : These film festivals are part of the mutual exchange programmes. What is intended is to show the culture of those countries to the people in our country, and our films depicting our way of life are exhibited in those countries.
