- (b) if so, the cause of the accident and the nature of the casualties suffered?

The Minister of Railways (Shri C. M. Poonacha): (a) Yes. Sir.

(b) The accident was due to parting of the train on a rising gradient on account of which the train rolled back and entered the slip siding at Doiwala station. As a result of this accident, 5 persons, including the guard of the train, wee killed and 8 persons injured of whom 2 sustained grievous injuries.

Linking of Wages to Production in Public Undertakings

- (a) whether Government have formulated any scheme for linking a part of the wages of workers in public sector undertakings to production and/or productivity:
- (b) if so, the principal feature of the scheme; and
- (c) the action taken by Government to implement such a scheme?

The Minister of Industrial Development and Company Affairs (Shri F. A. Ahmed): (a) to (c). Government have not formulated any scheme as yet for linking of wages of workers in the public sector undertakings to production and/or productivity. This question has, however, been under examination. A team of Russian experts was invited for evolving a Scientific System of incentive payments to workers in public sector undertakings. The report of this Team was considered by a Sub-Committee the Chairmanship of the Labour and Employment Adviser of the Government. The report of this Sub-Committee is under consideration of the Government. A provision has been made in the draft Fourth Five Year Plan for the introduction of Incentive Schemes for workers in the Industrial Undertakings as a whole in the country both in private and public sectors.
