## SUNFLOWER

Research trials conducted with four sunflower varieties obtained from Russia reveal that there are good potentialities for introduction of sunflower. Accordingly, to supplement the information of research workers, a Centrally Sponsored Scheme for sunflower demonstrations has been sanctioned for implementation over an area of 900 hectares during 1971-72 with the objective of building up the technical competence of farmers for launching a phased programme for the development of

sunflower crop leading to a rapid increase in its production.
