## Welfare of Miners

\*141 SHRI SURENDRA BIKRAM Will the Minister of PARLIAMEN-TARY AFFAIRS AND LABOUR be pleased to state

- (a) whether Mines Safety Review Committee has made recommendations for the welfare of Miners, and
- (b) if so the main iccommendations and Government's reaction thereon?

THE MINISTRY OF PARLIAMEN-TARY AFFAIRS AND LABOUR (SHRI RAVINDRA VARMA) and (b) The reconstituted Mines Safety Review Committee at its first meeting on the 29th October, 1977 recommended inter-alia where an employee of a coal mine becomes disabled due to pneumocomosis or any other occupational dis ease due to mining, a member his family should be given employment temporarily or permanently depending upon the temporary or permanent nature of disablement This recommendation is under the consideration of the Government

The Committee also endorsed the proposal of Government to amend the 2576 L.S.—1.

Mines Rules, 1955, for providing for compulsory medical examination of persons employed or to be employed in mines. The draft of the proposed amendments has been issued for publication in the Official Gazette on 31st October, 1977.

SHRI RAVINDRA VARMA ually the number of accidents is not alarmingly on the increase As tar as fatal accidents are concerned, you compare the figures for this year and for the equivalent period of last year you will find that though the number of accidents has slightly gone up, the number of deaths has gone down both in the case of coal mines and non-coal mines Therefore, it can be observed that more emphasis is being laid on the mine safety regulations with the result that я number of fatalities has shown marked decline both in the case of coal and non-coal mines.

भी हुक्स चन्द कल्ल्याय मती महोदय ने यह स्वीकार किया है कि कोयला-खानों मे दर्घटनायें काफी बढी हैं। नेरी जानकारी है कि उनमे मरने वालो की सख्या भी बढ़ी है और यह स्थिति पिछले कुछ वर्षों से चली मा रही है। कोयला-बानो मे दुर्घटनाओं का मल कारण यह है कि खानो के मालिक बचाव के ग्रावश्यक उपाव नहीं करते हैं । जब इस्पक्टर किसी खान के सुरक्षा-उमाबों की जाब करने के लिए जाते हैं, तो वे खान-मालिक के उपलप में बैठ कर चाय-पानी करके वापस ग्रा जाते है. ग्रीर जाच नहीं करते हैं । क्या सरकार ऐसी व्यवस्था करेबी कि खानो की जाच सक्ती से हो, और जिस खान में कोई विट पाई जाये. उसके मालिक के खिलाफ कडी कार्यवाही की जाये. जिससे भविष्य मे खान-दुर्घटनाये कम हो, या बिल्कल न हो ? मली महोदय ने किसी खान-कर्मजारी के ग्रपग हो जाने पर उसके परिवार के किसी सदस्य को नौकरी देने की व्यवस्था की बात कही है। लेकिन इस पर सख्ती से इसल नहीं हा रहा है। सरकार इसके लिए क्या कदम उठाने जा रही है कि इस पर ग्रमल सख्ती से हो ?

SHRI RAVINDRA VARMA I shall try to remember the many questions that the hon member has raised

MR SPEAKER To the extent possible

SHRI RAVINDRA VARMA. To the extent my memoric power allows me He said according to his information the number of persons killed this year is higher than last year. The information we have is and we have no reason to believe that it is not as authentic or more authentic than the information the hon member has as far as coal mines are concerned, the number of deaths has gone down

from 169 to 166 and that in non-coal mines has gone down from 62 to 46. That is why I said there is a marked decline in the figures. As far as enforcement of the safety regulations is concerned, the House knows that after this government came to power, we have taken special measures to ensure that every attention is paid to the safety regulations. The Review Committee which was constituted to review the implementation of the recommendations of the safety conferences is now meeting regularly. During the last two years .t had become a casualty of the Emergency and after two meetings this Committee never met since 1975 Now this Committee has been enlarged made more representative to include representatives of all trade union organisations that are related to coal fields and we have made it amply clear that this Review Committee must meet every quarter and must review the implementation of safety regulations I can, therefore. assure the hon. Member that every step is being taken by us to see that the safety regulations are honoured

SHRI RAVINDRA VARMA As far as this question is concerned, if you permit me to answer it as you have permitted him to put the question, I would say that we are taking every step to see that inspections are carried out regularly and enquiries are made promptly and action is taken on the results of the enquiries promptly

SHRI RAVINDRA VARMA: First of all, I wish to say once more categorically that it cannot be said that the number of accidents has increased darmingly.

SHRI RAVINDRA VARMA: Secondly, as far as the other question is concerned, the main causes of the accidents that have been identified are the fall of roof, the fall of sides and accidents happen sometimes as a result of use of explosives or asphyxiating gases and water levels in these mines. In regard to all these, we have taken steps.

SHRI RAVINDRA VARMA: There are many causes for mine accidents and the hon. Member has referred to one of them. In the recent meeting of the Review Committee some attention was paid to this aspect as well and it was decided that satisfies of accidents should be analysed both from the point of view of what happens above ground and what happens underground in the mines.

As far as the second part of his question is concerned, I can say that we will take every step necessary to see that negligence and non-fulfilment of the safety regulations are not the causes of any accident.
