(a): Sarva Shiksha Abhiyan (SSA) was operational till 2017-18 and now this stands subsumed in Integrated Scheme for School Education – Samagra Shiksha effective from 2018-19. The details of Central share released under SSA/Samagra Shiksha (Elementary Education) during the years 2015-16, 2016-17, and 2017-18 and 2018-19 in respect of Andhra Pradesh are as under:

(b): No delay has occurred.
