NO. 2944. SHRI RAJENDRA DHEDYAGAVIT:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether the Government has achieved its target in urban areas in Palghar in Maharashtra under Pradhan Mantri Awas Yojana; and**
- (b) if so, the number of beneficiaries given houses under this scheme, district-wise?**

(a) Under Pradhan Mantri Awas Yojana (Urban) [PMAY(U)], States/ Union Territories (UTs) are required to undertake a demand survey assessment and validate the same to determine the requirement of houses to be covered under the scheme. For urban areas in Palghar in Maharashtra, demand has been registered for 1,13,351 houses out of which 85,461 houses have been sanctioned as on 25.11.2019.
