(a) to (c) As per the information available as on 18th November 2019, five (5) proposals concerning Solapur District of Maharashtra are pending for Environmental Clearance in this Ministry. The list of the proposal is at Annexure. A total of Thirteen (13) proposals have been granted Environmental Clearance in the district during the last three years in Solapur District. There is no available information regarding any pending proposal from Solapur University during the last three years.
