MAJOR IRRIGATION PROJECTS

Will the Minister of JAL SHAKTI be pleased to state:

- (a) the details of under construction major irrigation projects, State-wise; and
- (b) the details of funds allocated for all these projects and disbursed till date?

ANSWER

(a) & (b) The Water Resources Projects are planned, funded, executed and maintained by the State Governments themselves as per their own resources and priority. In order to supplement their efforts, Government of India provides technical and financial assistance to State Governments to encourage sustainable development and efficient management of water resources through various schemes and programmes such as Accelerated Irrigation Benefits Programme (AIBP) etc. under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY).

During 2016-17, ninety-nine (99) on-going Major/Medium/ERM irrigation projects (and their 7 phases) under PMKSY-AIBP having ultimate irrigation potential of 76.03 lakh hectare and balance estimated cost of Rs.77595 crore [Central Assistance (CA) component of Rs.31342 crore] have been prioritized in consultation with States for completion in phases. Funding mechanism through NABARD has also been approved by the Government for both Central and State Share. Further, State-wise details of these prioritized projects including CA released during 2016-20 are at **Annexure**.
