Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the total number of registered and unregistered In-Vitro Fertilisation (IVF) clinics functioning in the country, State/UT-wise;
- (b) whether Government has formulated any guidelines for the functioning of these clinics, if so, the details thereof and if not, the reasons therefor;
- (c) whether the Government has received any complaints against sex selection/detection by IVF centres;
- (d) if so, the details thereof along with the steps taken/being taken by the Government against such centres; and
- (e) whether the Government has received any proposals from the State Governments to establish IVF centres specially in the Government hospitals and if so, the details thereof and the action taken by the Government in this regard?

- (a): Details as per National Registry of Assisted Reproductive Technology (ART) Clinics and Banks in India, maintained by the Indian Council of Medical Research (ICMR), are annexed as Annexure.
- (b): Government has not formulated guidelines so far. However, ICMR has developed National Guidelines for Accreditation, Supervision and Regulation of ART Clinics in India and these guidelines have been circulated to all States/UTs.
- (c)&(d): No. However, a complaint has been received by ICMR against a call centre named Ela Woman Fertility and the same is under examination.
- (e): Yes. A proposal was received from Kerala State for establishment of IVF centre at E.K. Nayanar Memorial Women & Child Hospital at Mangattuparamba, Kannur District in the National Health Mission-PIP. The same is under process.
