(a): The length of rural roads constructed and average length of road constructed per day under the Pradhan Mantri Gram Sadak Yojana (PMGSY) during the last three years and the current year till 27<sup>th</sup> February, 2020 are as under:-

(b)to (c): The unit for PMGSY is a Habitation and not a Revenue village or a Panchayat. The connectivity status of eligible habitations in core network in percentage terms by all weather roads under PMGSY in March, 2016 and as on 27<sup>th</sup> February, 2020, State-wise is given at **Annexure**.
