FUNDS ALLOCATED TO NORTH EASTERN STATES

3203. SHRI LORHO S. PFOZE:

Will the Minister of MINORITY AFFAIRS be pleased to state:

- a) the details of funds allocated to North Eastern States under various schemes implemented by the Ministry, year and State-wise during the last five years;
- b) the details of funds allocated to and spent by North Eastern States especially Manipur for the said schemes during the last five years; and
- c) the details of the funds allocated/spent in the valley and hill areas of Manipur?

ANSWER

(a) to (c): The Government has implemented various schemes for the welfare and upliftment of every section of the society including minorities especially the economically weaker & lesser privileged sections of the society with schemes like Pradhan Mantri Jan Arogya Yojana (PMJAY), Pradhan Mantri Mudra Yojana (PMMY), Pradhan Mantri Kisan Samman Nidhi (PM KISAN), Pradhan Mantri Ujjwala Yojana (PMUY), Pradhan Mantri Awas Yojana (PMAY), Beti Bachao Beti Padhao Yojana, etc. Ministry of Minority Affairs also implements programmes/ schemes for socioeconomic and educational empowerment of the six (6) centrally notified minority communities namely Christians, Sikhs, Buddhists, Muslims, Parsis and Jains. The schemes/programmes implemented by the Ministry in brief are as under: -

(A): Educational Empowerment Schemes:

The Educational Empowerment Schemes are:-

1. Pre-Matric Scholarship Scheme
2. Post-Matric Scholarship Scheme
3. Merit-cum-Means based Scholarship Scheme
4. Maulana Azad National Fellowship Scheme
5. Naya Savera - Free Coaching and Allied Scheme

6. Padho Pardesh
7. Nai Udaan

(B): Employment Oriented Schemes:

The Employment Oriented Skill Development schemes are:-

1. Seekho Aur Kamao
2. USTTAD (Upgrading the Skills and Training in Traditional Arts/Crafts for Development)- Hunar Haats are being organised across the Country to provide employment opportunities and markets to artisans/craftsmen.
3. Nai Manzil
4. Nai Roshni

(C): Infrastructure Development Programme:

Pradhan Mantri Jan Vikas Karyakram (PMJVK) - The scheme aims to provide basic infrastructure such as Schools, Colleges, ITIs, Polytechnics, Hostels, Sadbhav Mandap, Skill Development Centres, Drinking water and Sanitation facilities, Health Projects including hospitals, Sport facilities, Smart classrooms, Aanganwadi Centers etc. in deprived areas of the Country. The scheme is implemented in the identified areas having minimum of 25% minority population and backwardness parameters below the national average in respect of socio economic or basic amenities or both.

The Schemes which are implemented are all Central Sector Schemes, except for Pradhan Mantri Jan Vikas Karyakaram (PMJVK) which is a Centrally Sponsored Scheme. Under PMJVK, the Ministry releases its share for the approved projects to States who in turn spend the fund for the development of projects.

During the last five years, this Ministry has approved following major projects for North Eastern States including the State of Manipur: 4465 Additional Classrooms/Blocks, 1330 Anganwadi Centres, 45 Common Service Centres (CSCs), 01 Culture Centre, 02-Degree Colleges, 8552 Drinking Water Supply projects, 182 Hostels, 01 Hunar Hub, 3254 Indira Awas Yojana (IAY) Houses, 01 ITI, 11 Working Women Hostels, 5057 Smart Classrooms, 52 Sports related projects, 356 School Buildings, 50 Residential Schools, 109 Sadbhav Mandaps, 316 Health related projects (Health centres/equipments), 01 Hospital, 816 Toilets, 06 Skill Centres, etc. The details of funds allocated for North Eastern States under PMJVK, State-wise and year wise, including the State of Manipur, during the last five years is at Annexure I.

Details of fund sanctioned/utilised under Pre-Matric, Post Matric and Merit-cum-Means based Scholarship is at Annex II & details of funds sanctioned under Padho Pardesh scheme in all North Eastern States including the State of Manipur is at Annexure III.
