MISMATCH BETWEEN GROWTH OF FPIs

1491. SHRI G.M. SIDDESHWAR:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether the Government has done any realistic assessment of a mismatch between the growth of food processing industries and stagnant farm income, despite tremendous potential in food processing industries;
- (b) if so, the details thereof;
- (c) the major steps that the Government has taken to create a cold chain infrastructure in different parts of the country; and
- (d) the number of mega food parks that have so far been established in the country under Pradhan Mantri Kisan Sampada Yojna (PMKSY) along with details on their distribution?

ANSWER

(a) & (b): Food processing industries source most of the raw materials from farmers. Therefore, growth of the sector will have positive impact on farmer's income. However, farmer's income is not dependent only on this source.

Ministry of Statistics and Programme Implementation through national level surveys bring out data on income of agricultural households including net receipt from farming of crops and animals. The average monthly income of agricultural households has grown positively along with growth in Gross Value Added (GVA) of food processing sector in recent years as indicated in the table below:

(c): The Government is implementing various schemes to create cold chain infrastructure in different parts of the country as under:

- i. Ministry of Food Processing Industries is implementing a Scheme for Integrated Cold Chain, Value Addition and Preservation Infrastructure as one of the components of Pradhan Mantri Kisan Sampada Yojana (PMKSY) with the objective of reducing post-harvest losses of horticulture and non-horticulture produce and providing remunerative price to farmers for their produce.
- ii. Department of Agriculture & Farmers Welfare is implementing the Mission for Integrated Development of Horticulture (MIDH) for various horticulture activities including setting up of cold storages through State Governments.
- iii. National Horticulture Board (NHB) is implementing a scheme namely “Capital Investment Subsidy for Construction/ Expansion / Modernization of Cold Storages and Storages for Horticulture Products”.

(d): 41 Mega Food Park projects have been approved and 22 Mega Food Parks have been made operational in the country. A list of these 41 Mega Food Parks including their location is attached at **Annexure**.
