- (a) the year-wise details of the quantity of buffer stock of foodgrains maintained by the Food Corporation of India from the year 2014 to 2022;
- (b) the year-wise quantity of foodgrains diverted from the buffer stock for ethanol production from the year 2014 to 2022; and
- (c) the district-wise details in Uttar Pradesh?

(a): The total stock of foodgrains held in Central Pool as on 1st April (2014, 2015, 2016, 2017, 2018, 2019, 2020, 2021 and 2022) is as given below:

(b): There is no diversion of foodgrains from the buffer stock of foodgrain in the central pool. With a view to increasing production of fuel grade ethanol for blending with petrol, Government enables distilleries to produce ethanol from surplus rice available with FCI. For the period of December'2020-November'2021 i.e. Ethanol Supply Year (ESY) 2020-21,81044 MT of FCI rice was allocated to distilleries @ Rs. 20/kg ex-FCI godown for production of ethanol out of which 49233 MT was lifted by distilleries for production of ethanol. In the current ESY 2021-22, 842849 MT of FCI rice has been allocated to distilleries @ Rs. 20/kg ex-FCI godown for production of ethanol out of which 71607 MT was lifted by distilleries till 27.03.2022.

(c): No allocation of rice so far has been done for ethanol production from foodgrains for UP region.
