POVERTY ALLEVIATION SCHEMES

2301. SHRI D.K. SURESH: SHRI HAJI FAZLUR REHMAN:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether the Government has provided financial assistance to the States in order to deal with the problem of poverty;
- (b) if so, the details thereof and if not, the reasons therefor;
- (c) the details of the families living below poverty line, State-wise;
- (d) the details of Centrally sponsored schemes introduced for poverty alleviation in the country;
- (e) whether all the said programmes have achieved the targets set thereunder; and
- (f) if so, the details thereof and if not, the reasons therefor?

ANSWER

MINISTER OF RURAL DEVELOPMENT (SHRI NARENDRA SINGH TOMAR)

- (a) & (b): Multi-pronged strategies are being taken by the Ministry of Rural Development to address rural poverty and improve the economic well-being of the people in rural areas with the main focus on increasing livelihood opportunities, empowering rural women, providing social safety net, skilling of rural youth, infrastructure development etc through its programmes viz. Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS), Deendayal Antyodaya Yojana National Rural Livelihoods Mission (DAY-NRLM), Deen Dayal Upadhyay Gramin Kaushalya Yojana (DDU-GKY), Pradhan Mantri Awaas Yojana Gramin (PMAY-G), Pradhan Mantri Gram Sadak Yojana (PMGSY), Shyama Prasad Mukherjee National RuRBAN Mission(SPMRM) and National Social Assistance Programme (NSAP). The Budget allocation and expenditure for implementation of major Rural Development Programmes in various States/UTs during the last two years and current year is at **Annexure-I**
- (c) The estimation of poverty using poverty line had been done by the erstwhile Planning Commission (now NITI Ayog). The Ministry of Rural Development had been conducting Below Poverty Line (BPL) Census to identify the poor households in the rural areas. The first BPL Census was conducted in 1992, and then in the year 1997 and the last one in 2002.

After 2002 BPL Census, recognizing the multi-dimensional nature of poverty, Socio Economic and Caste Census 2011 (SECC 2011) was conducted in association with the States/UTs. SECC-2011 provides data of households on various aspects of their socio-economic status viz., housing, land-holding/landlessness, educational status, status of women, the differently abled, occupation, possession of assets, scheduled caste/ scheduled tribe (SC/ST) households, income, etc. The beneficiaries under several schemes of Government of India as well as many state governments are selected based on the (i) "automatically excluded households", (ii) "automatically included households" and (iii) "deprived households" data of SECC-2011. The State/Union Territory— wise numbers of rural households in these three categories are given at **Annexure-II.**

(d) to (f): The details of Centrally Sponsored Schemes of the Ministry of Rural Development for poverty alleviation and achievements under these schemes are given below:

Deendayal Antyodaya Yojana-National Rural Livelihoods Mission (DAY-NRLM) is a centrally sponsored anti-poverty programme launched in June 2011. The Mission seeks to reach out to all rural poor households in a phased manner and impact their livelihoods significantly. DAY-NRLM has been designed to be implemented in a Mission mode, with both the GoI and the states sharing the cost. The Mission has covered 6360 blocks spread over 691 districts across 28 States and 6 UTs up to January' 2021. The achievement under the scheme for the previous year and the current financial year is given below:

There are two skill development programmes for rural poor youth under DAY-NRLM, namely, **Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY)**, and **Rural Self Employment Training Institutes (RSETIs)**. Both these schemes are aimed at increasing employability of rural poor youth either for wage or self-employment. The achievements under these schemes are given below:

Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY)

During the FY 2020-21, training activity remain suspended over considerable period due to lock down following advent of Pandemic Covid19 resulting in affecting achievements of desired training targets.

Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) is a demand driven wage employment programme which provide for the enhancement of livelihood security of the households in rural areas of the country by providing at least one hundred days of guaranteed wage employment in every financial year to every household whose adult members volunteer to do unskilled manual work. During FY 2019-20, 265.36 crore persondays were generated and in the current FY 2020-21(as on 03.03.2021), 354.17 crore persondays have been generated under Mahatma Gandhi NREGS.

National Social Assistance Programme (NSAP) is a social welfare programme for the aged, widows, disabled and in the cases of death of the primary breadwinner belonging to Below Poverty Line (BPL) Households. It is 100% centrally funded Central Sponsored Schemes (CSS) implemented in the entire country including rural and remote areas. During the FY 2019-20, a total of 2.93 crore beneficiaries were covered under the scheme. In the current FY 2020-21, out of the total target of 3.09 crore, a total of 296 lakh beneficiaries have been covered under NSAP.

Pradhan Mantri Awaas Yojana-Grameen (PMAY-G) aims to provide a pucca house with basic amenities to all rural houseless households and households living in kutcha and dilapidated house upto two rooms in rural areas by 2022. The achievements under PMAY-G for FY2019-20 and current FY 2020-21 are given as under:

Pradhan Mantri Gram Sadak Yojana (PMGSY) was launched in the year 2000 as a measure towards alleviation of poverty in rural areas by providing access to basic services to the rural population by providing them good quality roads. PMGSY has helped in better

access of market place for the rural masses and generate employments in various forms. Since inception till 28th February 2021, a total of 7,50,896 km road length has been sanctioned, out of which 6,50,458 km road length has been completed (87%). Moreover, 99% habitation connectivity has been achieved under PMGSY.

Under Shyama Prasad Mukherji Rurban Mission (SPMRM), the Government proposes to develop 300 Rurban rural clusters in the country. SPMRM is intended for a holistic development of the selected clusters of villages. The scheme is aimed to achieve an integrated development, which effectively reduce the poverty by encouraging cluster growth. The physical progress under the SPMRM is given as under:
